

JL FIRE PROTECTION CABINET ALARMS

Protect cabinet contents from tampering by adding an alarm that sounds when the cabinet is opened or the equipment moved.



COMMANDER ALARM (CA)

A audio alarm that sounds when the cabinet door is opened.

- Installs on inside of cabinet.
- Plunger switch is activated when the cabinet door is opened.
- 85dB warning horn sound alert.
- Alarm is deactivated when the door closes, or may optionally be set up to stop in 2 minutes.
- 9-Volt battery not included. (Part # 14-9V)
- One year warranty.

Note: This alarm for surface mount cabinets and Embassy style cabinets must be factory-installed at the time of order.

STROBE ALARM (SA)

Add this top-mounted visual strobe light with 110 dB audio alarm to the Commander Alarm.

- Sounds an 110 dB warning horn and flashes strobe light when door is opened.
- On cabinets with at least 3" or wider trim, the strobe alarm will be installed. For cabinets under 3" wide trim, the alarm will be shipped loose for installation on the wall.
- One year warranty





Note: This alarm only operates when connected with the Commander Alarm

BRIGADIER ALARM (BA)

Can be installed with a magnetic door contact or a clip through the cabinet contents such as a fire extinguisher.

- Can be used with magnetic door contact (mounted on door jamb) or steel clip activation switch (through handle or under extinguisher)
- Sounds an 105 dB warning horn when the seal is broken or door is opened.
- Alarm stays on until cord is plugged back into the alarm unit.
- Deactivation pin included for servicing.
- 9-Volt battery not included. (Part # 14-9V)
- One year warranty.
