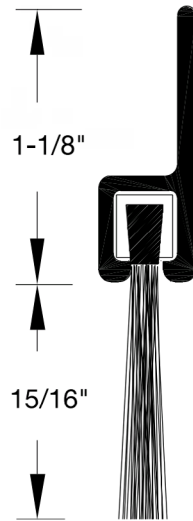


## DOOR BOTTOMS- DOOR BOTTOM SWEEP/WEATHERSTRIP - WT-967

Used as a door bottom sweep or weatherstrip to seal the perimeter of doors. The WT-967 has a black nylon brush.



### SPECIFICATIONS:

**Material:** 6063-T5 Aluminum

**Standard Finish:** Clear anodized

**Insert:** Nylon brush

**Fasteners:** Zinc-plated steel #6 x 5/8" Phillips pan head self-tapping sheet metal screws, use 7/64" drill bit (6" hole spacing)

### Sizes:

**Minimum:** 6"

**Maximum:** 184"

Order size listed is exact cut size

### TESTING:

**Fire Rated:** UL Classified per UL10B, CAN/ULC-S104, UL10C for use on listed steel frames and/or classified hollow metal and steel covered composite type fire doors rated 3 hours, wood composite to 1-1/2 hours, wood core type rated 20 min without hose stream.

**Smoke and draft control:** UL classified UL10C and UL 1784 Air Leakage Category H for use on "S" labeled doors

### OPTIONS:

**Material Finishes:** Black anodized aluminum, mill finish, dark bronze anodized aluminum

**Fasteners:** #6 Tek screws (self-drilling, self-tapping)
