

SUBMITTAL: FIRE-RATED FX SECURITY/DETENTION FIRE EXTINGUISHER, VALVE AND HOSE CABINETS PAGE 1 OF 3

JL security and detention cabinets for fire extinguishers, fire hoses or fire department valves are constructed to meet maximum security requirements in areas where fire protection is required. All recessed models have heavy-duty masonry anchors welded to the frame and a wide selection of lock preps and locks.

Fire-Rating: The recessed and semi-recessed Fire-FX™ cabinets are Intertek listed and labeled as an approved membrane penetration firestop system for up to 2 hours in accordance with ASTM-E814 when properly installed in a wall assembly according to installation instructions. The installation of this fire-rated cabinet which lacks a cabinet door or a condition in which the door is left ajar, will void the fire rating.

SPECIFICATIONS:

Door & Trim: 12 gauge (0.27 cm) steel with white powder coat finish or 14 gauge #4 satin finish stainless door. Flush cabinet doors are mounted in a 5/8" door stop and attached by a heavy-duty continuous hinge.

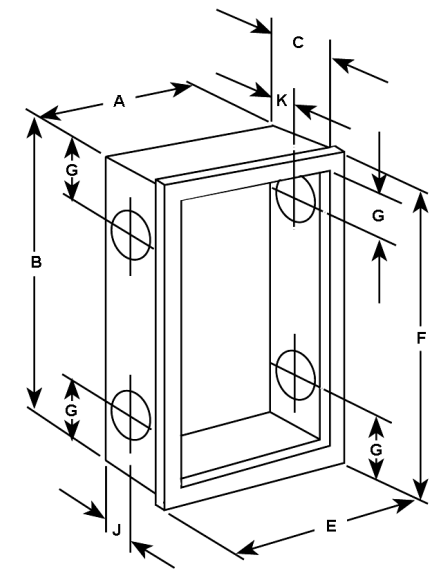
Trim Style & Depth: 1-1/2" wide trim on frame. Available in *Recessed* with flat trim, *Semi-recessed* with 2-1/2" deep square profile trim.

Tub: FX models feature an inner tub of the same material and finish as the frame surrounded by fire-resistant material, and a painted steel, outer tub. Heavy-duty masonry anchors are provided on recessed & semi recessed models.


Locks: See page 2 and 3 for lock and lock prep choices.

Knockouts: Knockouts are not provided on Fire-Rated Cabinets. Instructions for Knockouts in the field are provided, and must be strictly adhered to, to maintain fire rating.

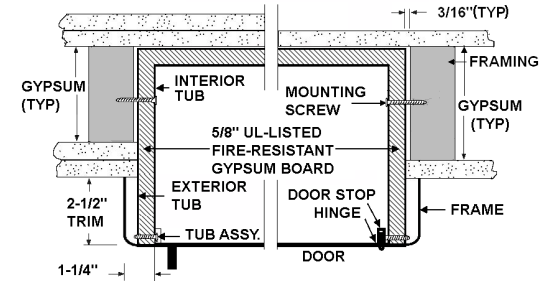

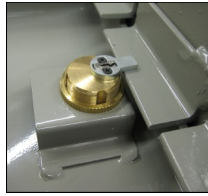
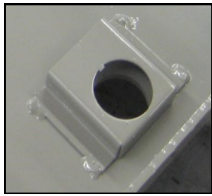

**MORTISE CAM LATCH**

MCP: Prepped for mortise cylinder lock by others. Cylinder lock must be: 1-1/8" diameter x 1-1/4" long mortise cylinder with standard cam. Cylinders by others require threaded locknut ring.

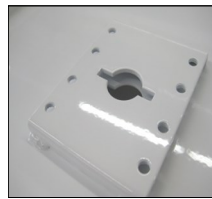
MCP-02: Includes installed mortise cylinder Kaba Ilco 7205SC1, 1-1/8" Dia x 1-1/4" long mortise cylinder with standard cam (PN: 06431), 2 keys (PN: 06431-KEY) and lock nut ring (PN: 0646).

MORTISE DEADBOLT

MDP: Prepped for mortise deadbolt cylinder lock by others. Cylinder lock must be: 1-1/8" diameter x 1-1/4" long mortise cylinder with Adams Rite cam. Longer lengths require adjustable lock collar (PN: SL-ALC).

MDP-03: Includes installed Kaba Ilco 7205SC2, 1-1/8" x 1-1/4" long mortise cylinder with Adams Rite cam (PN: 06441) and includes 2 keys (PN: 06431-KEY).

MDP-07: Includes installed temporary construction core mortise deadbolt cylinder Best 1E74C181RP3626, 1-1/8" diameter x 1-1/4" long mortise cylinder with C181 Adam Rite cam (PN: SL-1E74). Operation key (PN: 040004) & control key (PN: 040005) to remove the construction core ordered separately.

**DETENTION SLAM LOCK**

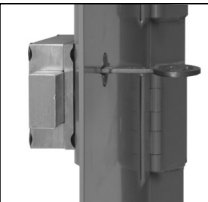
DSPP-25: Prepped for detention slam lock Airteq 5017 with standard bevel by others.

DSPI-25: Includes installed Airteq 5017 medium security for slam-locking with stainless steel latchbolt 1" x 7/16" bolt throw (PN: DDI-5017). Keys sold separately (PN: DDK-5017).

DETENTION DEADBOLT

DDPP-17: Prepped for detention deadbolt lock Airteq 5010. This mounting also accommodates Southern Folger 1010A.

DDPI-17: Includes installed Airteq 5010, medium security deadbolt, with zinc plated steel bolt 1-1/2" x 3/4" and 5/8" bolt throw (PN: DDI-5010). Keys sold separately (PN: DDK-5010).

**DETENTION DEADBOLT MOGUL LOCK**

MLPP-19: Prepped for detention deadbolt with mogul cylinder Airteq 5010M.

MLPI-19: Includes installed Airteq 5010M medium security deadbolt with mogul key cylinder, zinc plated steel bolt 1-1/2" x 1/2" and 5/8" throw (PN: DDI-5010M). Includes 2 keys (PN: DDK-5010M).
