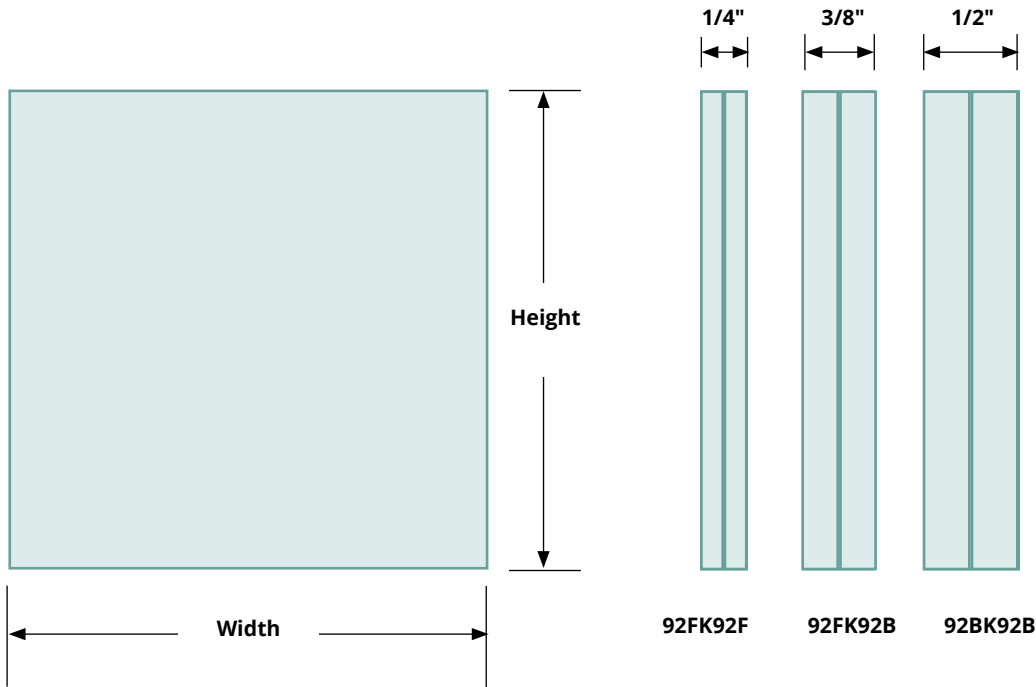


GLAZING - TEMPERED LAMINATED - LAMI - Non-Fire-Rated Safety Glazing
